

J. Sherman motions to approve the minutes of 11-30-15. Second by T. Bergeron.

Vote: 5-0-0 Motion passes.

FIRE DEPARTMENT PRESENTATION BY JIM PECK

Jim states the Fire Department is celebrating their 100th anniversary this year. On August 19th 1915 the Plaistow Volunteer Fire Company was founded. There was a report written by Walter Libby about the need for establishing the Fire Department. A framed copy of the report is presented to Chief McArdle by Jim Peck. Pauli Johnson presents her framed charcoal drawing of the 1926 Pumper Truck to Chief McArdle. Her drawing won a prize at Old Home Day Art Show. Chief McArdle thanks both Jim Peck and Pauli Johnson and states the 1926 Pumper Truck is owned and maintained by the Firemen's Association.

REVIEW OF 2016 PROPOSED WARRANT ARTICLES

Article P-16-16: Salary increase for the Town Clerk is discussed. The Town Clerk is an elected position and therefore different from that of other town employees. The State vehicle registration fee increased from \$1.00 to \$2.00 per vehicle in July to support an increase in the Town Clerk salary. The increased revenue will more than offset the proposed salary increase. Discussion ensues regarding the wording the of warrant article.

J. Kiszka inquires if the fees should be used for a salary increase. S. Ranlett responds yes, that is the purpose for the fees.

J. Sherman motions to have the BOS submit a warrant article for a raise for the Town Clerk similar to what was presented tonight but with a provision that the wording could and would change. Second by S. Ranlett.

Vote: 4-1-0 J. Sherman

Motion passes.

BUDGET REVIEW

S. Fitzgerald begins by stating it is still a little early for review if the utility lines. He used the November report from the US Energy Detailed Report Analysis of the 2016 projected fuel costs. Using this report in combination with the Town's utilization he is recommending the total fuel costs be reduced by \$8,800. A schedule of line items to be adjusted is presented by S. Fitzgerald.

J. Sherman motions to adjust the gas utility line items as presented for a total reduction of \$8,800 in the 2016 proposed budget. Second by T. Bergeron.

Vote: 5-0-0 Motion passes.

PROPOSED WARRANT ARTICLES

S. Fitzgerald states he drafted a new warrant article for the waterline but did not submit it tonight. Next year, NH DOT will be working on widening a segment of Rte. 125 and in prior years, the Town has appropriated funds for the project to extend the waterline. Currently there is \$450,000 in the Waterline impact fees raised by commercial properties that are tied into the waterline. These funds can only be used to expand or maintain the current fire suppression system.

S. Fitzgerald recommends using \$340,000 to expand the water line in conjunction with the Rte. 125 widening project.

Discussion ensues. The Board would like legal advice from Attorney Kalman to ensure the Board is able to expend the funds without a warrant article. This is deferred to next week once legal advice is received.

The Human Services/Red Cross Donation is discussed next. In October, Tiffany McKenna of the American Red Cross made a presentation to the Board requesting funds. More information was requested but never received.

J. Sherman motions to withdraw the warrant article requesting funding due to lack of information. Second by J. Ingerson.

Vote: 5-0-0 Motion passes.

Citizens Petitioned Warrant Articles and the process of bringing one to appear on the ballot is discussed. It is noted that a form with the correct number of signatures must be completed and brought to the Town Clerk. The resident submitting the warrant article must write it as the Board of Selectmen cannot change the content of a Citizens Petitioned Warrant Article. It is noted there are some citizens interested in presenting a warrant article to change the elderly

exemption. The Board discusses whether they should initiate a warrant article to change the exemptions.

- S. Ranlett polls the Board to inquire if the Board should submit a warrant article for the elderly exemption or if we want to leave it as a citizen's petition.
- J. Sherman undecided, J. Ingerson yes, J. Kiszka yes, S. Ranlett yes, T. Bergeron no.

The Board determines they should confirm when the current exemption figures were last adjusted, and apply a cost of living increase to come up with an adjusted exemption amount.

J. Sherman motions to direct the Town Manager to produce a recommendation for adjusting both the elderly and disabled tax exemptions based upon cost of living changes since these numbers were established. Second by J. Kiszka.

Vote 5-0-0

Motion passes.

J. Ingerson requests a copy of the application for elderly and disability exemption and the rules for completing it.

It is noted the warrant article for a solar exemption is not complete and will be reviewed next week.

J. Sherman would like the Board to review all the warrant articles and revote on them for final wording. S. Ranlett agrees.
