# **Recognition of Police Officers Myles Mastrototaro & Brandon Thibault**

Police Chief Santoro states he would like to recognize two of the departments' officers who responded to a home invasion/robbery and multiple crime spree in Hampstead (prior to his tenure in Plaistow). The officers were instrumental in securing the crime scene. They also assisted State, local and Sherriff's Departments officers. The officers are Myles Mastrototaro and Brandon Thibault. These officers will be recognized later in the month at the NH State House as they have earned a Congressional Award for their work on this case.

# **Discuss Town Forest Issues**

Jill Senter, Chair of the Conservation Commission states someone is making new, unauthorized trails in the Town Forest. Southeast Land Trust noticed the issue and brought it to the Conservation Commission's attention. In one area someone has cut into the trail banking. In other places trees have been cut down. Planks have been placed over wet areas for bikes to cross. It is unlawful and illegal to do such work in the Town Forest. Volunteers work hard to maintain the trail system. Plaistow Boy Scouts clean the trails twice a year. Some signs have been installed to try to deter the new trail work, yet the problem still exists. The Conservation Commission does not know what else to do.

There is consensus amongst the Board that the police department should be notified. An email notice should be posted on the Town's website. Southeast Land Trust should be asked to remove the planks. Lastly prosecution will be considered if the problem continues.

Conservation Commission Chair J. Senter states the Conservation Commission is holding a public hearing on November 9 regarding prime wetlands. All the abutter notices were mailed today. A warrant article will be proposed for the 2024 ballot.

Chair J. Senter also states the Conservation Commission is willing to financially support the recreation trails at Mt. Misery. They plan to cover the amount the grant would have covered. They would like to see the land put in an easement to prevent any future development.

## **Review the 2024 Town Managers Proposed Budget**

Town Manager Greg Colby states Department Heads have been working on their budgets since the end of August. The Finance Department assisted in compiling all the information together. Tonight's presentation is the culmination of all that work. The overall increase of the proposed 2024 budget is about \$1,078,509 or 9.5%. The bulk of this, \$687,671, is for ambulance service. Revenue will be generated from the ambulance service by billing health insurance companies. A conservative revenue estimate is \$400,000/year. Therefore the \$687,671 is not a direct impact on taxpayers. Without the ambulance service the budget increase is approximately \$390,838, about 3.44%. That is not bad considering the rate of inflation. It is not a level budget however it is close. Town Manager Colby states some of the larger budgets including police, fire, highway, recreation and the Library will have presentations by department heads at the next meeting scheduled for October 16.
