

PLAISTOW BOARD OF SELECTMEN MINUTES:

DATE: June 17, 2019

MEETING CALLED TO ORDER: 6:30 pm

A moment of silence was held for Selectman Kiszka uncle, retired Police Officer George Wickson, former Road Agent Al Hoyt, and Gerard LaRoche.

SMITH CORNER ROAD

On Friday, we were notified by the Highway Supervisor that there was a collapse of a culvert on Smith Corner Road. Over the weekend the Highway Department tried filling the hole, but the material was disappearing as quickly as it was being filled. Harry Stewart, Normandeau & Associates), Dee Voss and Dan Garlington met early Monday to contact NH DES to apply for an "Emergency Authorization" to repair and/or replace the failing corrugated metal pipe culvert that had collapsed. We received the "Emergency Authorization Verification" this afternoon. Town Manager is asking the Board of Selectmen to authorize the expenditure of "Contingency Funds" for enough funds to perform this work. We do not yet have an estimate from the contractor but expect to have it by Tuesday.

G Taillon motions to authorize the Town Manager to enter into an "Emergency Contract" with a construction and excavation contractor to perform the replacement of a collapsed culvert on Smith Corner Road in the initial amount of funding up to \$20,000 from the "Contingency Fund" and to return to the Board of Selectmen if more funds are needed. Seconded by J. Kiska.

Chapter 56 Conflict of Interest

Language is more straight forward and streamlined. G. Taillon discussed key updates with Steve Buckley by changing the language so that family members can serve on the committee. (See change below)

Family members serving on Town Committees or Boards does not preclude a town citizen from being elected and serving on the Conflict of Interest Committee. Members of the Conflict of Interest will recuse themselves when a petition is filed involving a family member.

Chapter 63 Excavations

Update: Violators of this article will be, upon conviction, subject to a fine of not more than \$250. Remove "which includes digging for coins".

Chapter 67 Firearms

Leave chapter as is.

Chapter 70 Fire Prevention

Article I Fire and Smoke Detectors updated in "red"

Any firm, person, or corporation violating any of the provisions of this article shall be deemed guilty of a misdemeanor and, upon conviction in the District Court, shall be subject to a fine not to exceed \$100 for each offense, and each and every day such violation continues it shall constitute a separate offense, with a maximum fine not to exceed \$800.

Article II Wood Stoves (add Pellet, Kerosene)

Any violation of this article may result in a fine not to exceed \$400.

Article III Unvented Space Heaters

A person violating any provision of the unvented space heater rules and regulations (state and local) shall be punished by a fine of not more than \$400 for each offense.
