REVENUE – SEAN FITZGERALD

J. Sherman states Revenue is a year behind that makes setting the tax rate difficult. The Budget doesn't set the tax rate, it is the revenues that make an impact and they are about a year behind.

S. Fitzgerald responds that Greg Colby has the check and will continue to hold on to it.

M. Curran offered to donate a frame for the check.

D. Poliquin spoke 1.6 million dollars is owed to the Town of Plaistow by the Beede Group. The BTLA has added to the problem.

R. Gray continued stating the Town did appeal the decision and the town was denied an appeal to the Supreme Court under the 4th amendment. This town was not allowed our day in court. It may take a change in law in order for us to get relief from this.

J. Sherman questioned the value of the building on the property?

S. Fitzgerald responded by stating the owners will not respond to questions related to the value of the building. They have made significant investments to the site.

R. Gray pointed out that the Tax Rate needs to be set by November 15th, per order of the board to the Town Manager.
