

Bracci states on page 2 under Renewal Audit Contract the dollar amount in the last sentence should be \$20,000 not \$24,000. He also states the motion for the contract should discussed, "S. TOWN MANAGER EVALUATION

- P. Bracci states this was his agenda suggestion. He states it may be better to wait until a full Board is available. He asks if other Selectmen have any suggestions regarding the email he sent.
- J. Kiszka states he does not agree with a numeric rating of 1-5 or 1-10. We previously agreed on a process. This should only be a mid-review, or status update on how the goals are going. Not a rating.
- F. Hart suggests categories of goals, such as goals met, goals not met or goals in progress. Then the categories could be further discussed. For example, are any goals not met still appropriate? We should update the goal list. She states if something went over budget that is on the Board not the Town Manager.
- S. Ranlett states that is not necessarily true as we have a bottom line budget.
- F. Hart thinks a numerical rating is micro-managing.
- P. Bracci states, no one responded to his email. Since no one likes it we should can it.
- F. Hart states we do not need to can it.
- J. Kiszka states he does not like a secret ballot.
- P. Bracci states his plan was to have discussion in public and just rate/grade goals in secret.
- F. Hart does not think that equals open and transparent government. She believes secret ballots are for cowards
- P. Bracci states he and J. Sherman will be gone in a month and they should be able to speak before they leave office and let new Selectmen see where things stand.
- M. Pearson states he is here to answer questions. His Town Manager Reports contain updates on the status of projects on a regular basis.

There is consensus to add this to the agenda for the next meeting.

LIBRARY TRUSTEES EMAIL TO SELECTMAN J. KISZKA

- J. Kiszka discusses an email he received from Jim Peck, Chairman, Plaistow Public Library Board of Trustees. The Library was recently informed by Carter Sprinkler company that the sprinkler heads in the Library attic are on a 20-year replacement cycle and they need to be replace. They also found out the heads ae on a recall list and need to be replaced regardless of age since there is a risk the sprinklers will not activate in a fire. They have a quote from Carter Sprinkler to replace the sprinkler heads for \$13,870. The Library Board of Trustees would like to know if the Selectmen are willing to use funds from the Town's Contingency Fund to help pay for the replacement.
- F. Hart states since there was a recall we should be able to get some type of refund or lower cost on the project.
- M. Pearson states the recall was about 15 years ago. He states he agreed to assist Cab Vinton, Library Director with the issue. He suggested C. Vinton set up a meeting with the head of the sprinkler company to do some negotiations. We should know when the recall first became known and who knew it. However, it is the Boards decision if they want M. Pearson to continue to assist C. Vinton.
- S. Ranlett recommends C. Vinton do as much as he can on his own. Both P. Bracci and J. Kiszka agree as M. Pearson is busy with several other issues.

RESIDENT VISIT

Sam Sainsbury, a Plaistow resident came into the meeting room and passed out letters to the Board members.

- S. Ranlett states this is a Planning Board/Zoning Issue and should not be discussed now.
- P. Bracci agrees, this should be squelched. Nothing should happen now.

The resident asks how he should proceed.

- J. Kiszka states the Board is not here to give advice.
- S. Ranlett recommends dropping the issue. It is not appropriate and the Board should not set a precedent for a meeting interruption.

The Board agrees not to proceed.

J. Kiszka thanks the resident for letter.
