COMMITTEE POWER COMMITTEE MINUTES October 4, 2023

Call to Order: 5:02 p.m.

Agenda Item 4: Community Power Update - Theresa MacDowell, Standard Power

Theresa MacDowell, Standard Power, was present for the discussion.

T. MacDowell distributed a final draft of the Plaistow Community Power Plan, which will be submitted to the Public Utilities Commission (PUC). There was a discussion regarding reaching out to civic organizations to help get the word out.

It was noted that there were 133 responses to the survey, 31 of which were blank.

There was a brief discussion about other municipalities that had recently launched their Community Power Programs, and what their initial rates were.

P. Bealo moved, second by W. Proctor, to recommend to the Board of Selectmen that the Plaistow Community Power Plan be approved.

D. Voss noted that Tim Moore had asked her to let the Committee know that he was all set with the Community Power Plan.

There was no additional discussion on the motion. The vote was 3-0-0 U/A.
