- A. In compliance with your Advertisement for Proposals, PROPOSER hereby proposes to perform all WORK for the Contract, in strict accordance with the CONTRACT DOCUMENTS, within the time set forth therein, and at the prices stated below, in accordance with all applicable laws.
- B. By submission of this PROPOSAL, each PROPOSER certifies, and in the case of a joint PROPOSAL, each party thereto certifies as to his own organization, that this PROPOSAL has been arrived at independently, without consultation, communication of agreement, as to any matter relating to this PROPOSAL with any other PROPOSER or with any competitor.
- C. PROPOSER hereby agrees to commence WORK under this Contract within ten (10) consecutive calendar days after a date to be specified in the contract authorization. If the PROPOSER fails to meet the SUBSTANTIAL COMPLETION date specified in the Contract Documents, the PROPOSER will be required to pay the OWNER liquidated damages for each calendar day that the Substantial Completion is not met.
- D. The undersigned acknowledges receipt of addenda numbered \_\_\_\_\_ through \_\_\_\_\_ inclusive.
- E. PROPOSER understands that the OWNER reserves the right to reject any or all proposals and to waive any informalities.
- F. ALL PROPOSALS shall remain open for sixty days, excluding Saturdays, Sundays and legal holidays, after the actual date of the General Proposal.
- G. The Proposal Security accompanying this Proposal shall be in the amount of five (5%) percent of the General Proposal.
- H. Amounts are to be shown in both words and figures, In the case of discrepancy, the amount shown in words will govern.

- I. The unit and lump sum prices shall include all labor, equipment, materials, overhead, profit, insurance bonds, etc. to cover the finished work of the several kinds called for.
- J. The quantities of WORK tabulated in the PROPOSAL or indicated on the drawings or in the specifications are only approximate and are subject to increase or decrease
- K. Any unit price proposal that contains a unit price which is unduly high or low may be rejected as unbalanced, and may be the basis of rejection of the proposal.
- L. The PROPOSER agrees that, if it is selected as General Contractor, it will within ten (10) consecutive calendar days after presentation thereof by the Awarding Authority, execute a Contract in accordance with the terms of this PROPOSAL and furnish a Performance Bond and also a labor and materials or Payment Bond, each of a Surety company qualified to do business under the laws of the State of New Hampshire and satisfactory to the Awarding Authority. Each Bond shall be in the sum of one hundred (100%) percent of the Contract Price, the premiums for which are to be paid by the General Contractor and are included in the Contract Price.
- M. In accordance with above understanding, the undersigned proposes to perform the WORK, furnish all material and complete the WORK in its entirety in the manner and under the conditions required at prices listed in the PROPOSAL FORM as follows:
